Act.1 Set the regulations for processing recruitment of full-time and adjunct teachers of center for Center of Teacher Education, according to "Establishment Regulations for Teacher Evaluation Committee", "Regulations Governing Appointment of University Teachers and Research Personnel", "Rules for Reviewing Qualification of Adjunct Teachers Recruitment", and "Establishment Regulations for Teacher Evaluation Committee of Institute of Education(hereinafter called "the teacher evaluation committee")".

Act.2 Other related procedures for recruitment of teachers of the institute are processed according to the recruitment regulations unless otherwise agreed.

Act.3 The qualification of recruitment of teachers of the institute shall be accord with "Regulations Governing Appointment of University Teachers and Research Personnel" Art.3, and the recruitment of new teachers shall be accord with "Rules for Reviewing Qualification of New Teachers Recruitment".

Act.4 The procedures of recruitment of new full-time teachers shall be accord with "Regulations Governing Appointment of University Teachers and Research Personnel", passed in the first review of the teacher evaluation committee, and sent to the Teacher Evaluation Committee of College of Social Science for second review. After the second review passed, it will be sent to the Teacher Evaluation Committee of the University for final review.

New recruited teachers should be accord with "Regulations Governing Appointment of University Teachers and Research Personnel", and also proceed outside paper-review of professional papers(including academic thesis) or technical reports written after previous degree, but the number of sent documents should be at most 10. The recruited teachers should choose one of the submitted documents as representative writings, and the others as reference writings, which belonged to the series of the related research should be combined to representative writings.

The above procedures of outside paper-review shall be accord with "Rules for Reviewing Qualification of Adjunct Teachers Recruitment".

Act. 5 The procedures of recruitment of new full-time teachers in the institute shall be accord with "Rules for Reviewing Qualification of Adjunct Teachers Recruitment".

Act. 6 Every recruitment case should be discussed with one recruited teacher and conduct voting by secret ballot.

Act. 7 Events related to first recruitment, second recruitment, long-time-recruitment, dismissal, suspension, discontinuation, other related events, and events that there's no referenced instruction in the rule are accord with "Regulations Governing Appointment of University Teachers and Research Personnel" and other related regulations.

Act. 8 The rules has been passed by the center conference, sent to and passed by the The Teacher Evaluation Committee of the College, and implemented after the president approved the rule; same as the rule edited.
